# FROM THE SHA PRESIDENT

I have been a member of many of the past Boards of which the following projects have been resolved:

- Crumbling clubhouse walls
- New annex building windows
- New stairway and entrance to clubhouse
- Shoreline erosion
- New parking lot asphalt
- New playground sets and swings
- Repair of pool wall
- Replacement of bridge rail supports
- Replacement of undersized electrical outlets
- New furniture cushions in clubhouse and annex buildings

These Boards, along with our KSN attorney, have addressed delinquent accounts, in spite of not assessing late fees in 2020 and 2021 due to the pandemic. Quarterly reconciliations of our bank accounts by an external CPA has improved the accuracy of our finances.

This past year the association was able to have the Easter Egg Hunt, Family Picnic, and the upcoming Fall Fest. We also held an outdoor movie night to welcome the autumn season. While the association had some issues finding lifeguards this summer, the pool was able to open during scheduled hours when weather permitted.

Speaking of the pool - The Board was told back in 2015 that the association needed to consider replacing the pool before it failed. Recently, the current Board has been given an estimate for replacing the pool and kiddie pool of around \$900,000. Before everyone panics, at present the pool reserve has about \$800,000 and should increase by \$88,000 next year before the replacement construction begins. The Boards have been able to accumulate the large reserve by aggressively addressing delinquent accounts, being very frugal with expenses and payroll.

With changing city, county and state laws, pool, and aging structure, there is a lot of work for the association in the next several years. On November 10, 2022 the Annual Board of Directors will be held. The association needs good candidates for directors. The association needs members for the architectural committee. It must be noted that the savings and completion of projects has improved since the architectural committee was started about 10 years ago. Also, consider helping out at any of our current and future events.

### FINAL BRUSH PICK-UP

The last brush pick-up for this year will be in October. Summerlakes falls within Zones 1 & 2.

Zone 1 (north of Batavia Road) - first Monday of October

Zone 2 (south of Batavia Road) - second Monday of October

Please keep in mind that brush is required to be out by 7:00 a.m. on the designated Monday, but pick-up may occur on a day later in that week.

Brush piles must comply with the following guidelines:

- One pile per address
- Pile cannot be greater than 3 feet in height, 8 feet in depth, and 15 feet in length
- Branches cannot be longer that 8 feet in length and no more than 8 inches in diameter
- Branches must be placed with the larger cut end toward the street

Brush pick-up is limited to trimmings (not tree removal) from bushes or shrubs, and branches from trimming and/or pruning trees. Other items such as logs, root balls, stumps, lumber, etc. will NOT be picked up. Brush piles that do not conform to these standards will NOT be picked up and a notice will be left on the front door.
